Resolution Of The City Council Of The City Of Emeryville Authorizing The City Manager To Execute A First Amendment Agreement With The County Of Alameda That Governs The Provision Of Emergency Medical Services And First Responder Advanced Life Support (FRALS) For The Term Of July 1, 2019 To June 30, 2026

WHEREAS, the City of Emeryville and the Alameda County previously entered into a First Responder Advanced Life Support (FRALS) agreement, whereby the City is authorized by the County to provide first responder paramedic level services, pursuant to the California Health and Safety Code and the California Code of Regulations; and

WHEREAS, the City Council previously approved a FRALS contract with the County of Alameda on November 1, 2011 and amended the contract on May 24, 2016, September 5, 2017, June 19, 2018 and June 18, 2019; and

WHEREAS, The City of Emeryville fulfills its obligations under the proposed agreement by way of its contract with the Alameda County Fire Department (ACFD). The ACFD staffs two FRALS units with engines at the Powell Street and Hollis Street fire stations. Section 3, Scope of Services, subsection a.3. Emergency Medical Response, of the Emeryville/ACFD contract provides that:

ACFD shall fulfill and does hereby assume City's obligations under the City's First Responder agreements with the Alameda County Emergency Medical Services (EMS) District which are hereby assigned to ACFD. ACFD's duty to fulfill the City's obligations under the First Responder agreements with the EMS District shall not affect the City's right to receive all revenue from the EMS District due to the City under [the agreement]; and

WHEREAS, the current FRALS agreement will expire on June 30, 2024; and

WHEREAS, the proposed new FRALS Agreement allows the City of Emeryville to continue to provide first responder paramedic services through June 30, 2026; now, therefore, be it

RESOLVED, that the City Council of the City of Emeryville authorizes the City Manager to execute an amendment agreement with the County of Alameda that governs the provision of the Emergency Medical Services and First Responder Advanced Life Support (FRALS) for the Term of July 1, 2019 to June 30, 2026, which services are provided by the Alameda County Fire Department for the City of Emeryville.
