Resolution Of The City Council Of The City Of Emeryville Approving The Proposed SB 1 Project List And Appropriation For Fiscal Year 2023/2024

WHEREAS, Senate Bill 1 (SB 1), Road Repair and Accountability Act (RRAA) of 2017 (Chapter 5, Statutes of 2017) was passed by the State Legislature and signed into law by the Governor in April of 2017 to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of Emeryville are aware of the projects proposed for funding in the community and which projects have been completed each fiscal year; and

WHEREAS, the City must include a list of all projects proposed to receive funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1, in the City budget, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the City will receive an estimated \$307,474 in RMRA funding for Fiscal Year 2023/2024; and

WHEREAS, this is the sixth year in which the City is receiving SB 1 funding and the funding will enable the City to continue essential road maintenance and rehabilitation projects, safety improvements, repairing and replacing aging bridges, and increasing access and mobility options for the traveling public that would not have otherwise been possible without SB 1; and

WHEREAS, the funding from SB 1 will help the City maintain and rehabilitate streets, roads and pedestrian infrastructure, and it will also add active transportation infrastructure throughout the City this year and many similar projects into the future; and

WHEREAS, the 2023 report of Emeryville's Pavement Management Program showed that the average overall network Pavement Condition Index (PCI) of the City's street network is 81, which indicates that the street network is in 'Good' condition, and this SB 1 funding will help the City to increase the overall quality of our road system over the next decade into an "excellent" condition; and

WHEREAS, the SB 1 Project List and overall investment in our local streets and roads infrastructure with a focus on basic maintenance and safety, investing in complete streets infrastructure, and using cutting-edge technology, materials, and practices, will have significant positive co-benefits statewide; and

WHEREAS, in addition to submitting an SB 1 Project List to the CTC, the SB 1 guidelines require that all proposed projects be included within an agency's budget, and the draft Capital Improvement Program budget includes this funding within the Sustainable Streetscapes Project (SUT-01); now, therefore, be it
