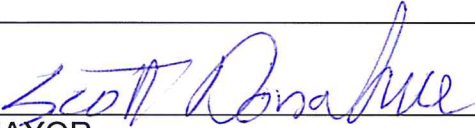
WHEREAS, the City of Emeryville serves as the Successor Agency to the Emeryville Redevelopment Agency; and
