RESOLVED, that the City Council of the City of Emeryville hereby authorizes the City Manager to execute Contract #CSPP-7008 with the State Department of Education, Office of Child Development, for the amount of \$150,572 in State funding for the Emeryville Child Development Center in the form attached hereto as Exhibit A; and be it further

RESOLVED, that the State funding be appropriated to account 230-53600 when received.
