Resolution Of The City Council Of The City Of Emeryville Authorizing The City Manager To Execute A First Amendment To The Professional Services Contract With Alta Planning + Design, Inc. To Prepare The Active Transportation Plan In An Amount Of \$60,000 To Cover Expanded Services For A Total Amount Not To Exceed \$425,000 And Appropriating \$60,000 From The General Plan Maintenance Fund Balance (Fund 225) To Account 80050, Professional Services, In The Fund 225 General Plan Maintenance Budget

**WHEREAS**, on November 17, 2020, the City Council adopted Resolution No. 20-114 authorizing the City Manager to execute a Professional Services Contract with Alta Planning + Design, Inc., to prepare the Active Transportation Plan (ATP) from November 17, 2020 to June 30, 2023 in an amount not to exceed \$365,000; and

**WHEREAS**, staff has identified additional items that can be addressed as part of the ATP process, specifically the creation of a wayfinding program and additional grant-writing assistance for projects contained in the ATP; and

**WHEREAS**, Alta Planning + Design, Inc. has proposed to provide these services for an additional fee not to exceed \$60,000, for a total amended contract amount not to exceed \$425,000; and

**WHEREAS,** the City finds that specialized knowledge, skills, and training are necessary to render the services necessary to do the work contemplated under this First Amendment; and,

**WHEREAS**, the City has determined that Alta Planning + Design, Inc. is qualified by training and experience to render such services; and

**WHEREAS**, Alta Planning + Design, Inc. desires to provide such services; and,

WHEREAS, the public interest will be served by this First Amendment; and,

**WHEREAS**, there is a sufficient fund balance in the General Plan Maintenance Fund (Fund 225) to cover the additional appropriation needed for this First Amendment; now, therefore, be it

**RESOLVED**, that the City Council of the City of Emeryville hereby authorizes the City Manager to execute a First Amendment to the Professional Services Contract with Alta Planning + Design, Inc., in substantial form as attached as Exhibit A to this Resolution, for an additional amount not to exceed \$60,000, for a total contract amount not to exceed \$425,000, for preparation of the Active Transportation Plan; and be it further

**RESOLVED**, that the City Council hereby appropriates \$60,000 from the General Plan Maintenance Fund balance (Fund 225) to Account 80050, Professional Services, in the Fund 225 General Plan Maintenance budget; and be it further
