RESOLVED, by the City Council of the City of Emeryville that Rob Fong is hereby appointed as Business Representative to serve on the Economic Development Advisory Committee for a term commencing June 17, 2025, and ending June 30, 2026; and, be it, further

RESOLVED, by the City Council of the City of Emeryville that Kyle Weddington is hereby appointed as Resident to serve on the Economic Development Advisory Committee for a term commencing July 1, 2025, and ending June 30, 2027; and, be it, further


RESOLVED, by the City Council of the City of Emeryville that Marchelle Huggins and David Kritzberg are hereby appointed as Small Business Representatives to serve on the Economic Development Advisory Committee for terms commencing July 1, 2025, and ending June 30, 2027; and, be it, further

RESOLVED, by the City Council of the City of Emeryville that the FY2025-26 Local Roster of Boards, Commissions and Committees is hereby amended to include the aforementioned appointments.

The City of Emeryville does not specifically prohibit concurrent service on more than one committee, provided, however, that the Government Code prohibition against incompatible offices shall apply. If a request were made to serve on more than one committee, a determination would be made as to whether that service would be allowable.
