**Resolution Of The City Council Of The City Of Emeryville Authorizing The City Manager To Retroactively Accept And Expend A FY 2024 State Homeland Security Grant On Behalf Of The Police Department In The Amount Of \$21,120 For Automated License Plate Readers And Increase The FY25/26 Budget By \$21,120**

**WHEREAS**, the Emeryville Police Department applied for and was awarded a grant from the FY 2024 State Homeland Security Grant Program (SHSGP) to purchase up to six fixed-mounted Automated License Plate Readers (ALPR); and

**WHEREAS**, the ALPR cameras to be purchased will enhance the department's ability to monitor vehicle movement in real time, increasing opportunities to deter criminal activity and rapidly respond to in-progress incidents, all while increasing ALPR coverage and enhancing situational awareness to ensure a more comprehensive layer of public safety; and

**WHEREAS**, the Police Department is requesting to increase both the revenue (254-51400) and expenditures (254-91510) for the department in the amount of \$21,120 to accommodate the initial expense and the reimbursement of funds from the State; and

**WHEREAS**, the Police Department will utilize the grant funds to expand its ALPR network to enhance public safety, improve vehicle-related investigations, deter criminal activity, and support real-time identification of suspect vehicles, stolen property, and persons of interest; now, therefore, be it

**RESOLVED**, by the City Council of the City of Emeryville that the City Manager is authorized to retroactively accept the FY 2024 State Homeland Security Grant (SHSGP) and appropriate expenditures in the amount of \$21,120 to accommodate the initial expense and the reimbursement of funds from the state and, be it, further

**RESOLVED**, by the City Council of the City of Emeryville that the FY25/26 Adopted Budget appropriates revenue of \$21,120 into Grant Fund 254 (account 254-51400) and appropriates expenditures of \$21,120 into the Grant Fund (account 254-91510).
