WHEREAS, on May 16, 2017 the Emeryville City Council approved the project scope of work and authorized Public Bidding the project once the plans and specifications were approved by the City Engineer (Resolution No. 17-72); and

WHEREAS, the Project was bid on July 27, 2017, in compliance with California Public Contract Code section 20162; and

WHEREAS, on August 17, 2017, the following bid proposal for the project was received: Telfer Pavement Technologies, LLC \$ 2,413,799.75; and

WHEREAS, the City of Emeryville reserves the right to reject any or all bids; and

WHEREAS, modification of certain requirements and items in the contract documents may result in more than one bid; and

WHEREAS, re-bidding the modified project and receiving multiple bids on this project would be in the best interest of the City's use of public funds; and

WHEREAS, staff proposes to modify the originally approved scope of work to split the project into two phases; and

WHEREAS, there is \$490,000 in Measure B and Measure BB funds allocated in the Annual Street Rehabilitation and Preventive Maintenance Program (CIP No. 17240005), an additional \$520,000 in Measure B funds that are available to be spent this year, and \$490,000 in funds that are available from the Revenue Bond Fund accounts; now, therefore, be it

RESOLVED, that the City Council of the City of Emeryville rejects all bids for the Annual Street Rehabilitation and Preventive Maintenance Project, EPW 17-104 (CIP No. 17240005); and be it further

RESOLVED, that the City Council of the City of Emeryville hereby approves the revised scope of work for the Annual Street Rehabilitation and Preventive Maintenance Project, EPW 17-104 (CIP No. 17240005); and be it further

RESOLVED, that the City Engineer is hereby authorized to advertise said project for Public Bids once the City Engineer has approved the plans and specifications.
