#### Why are you interested in serving on this Board, Commission or Committee?

I am interested in serving on the Planning Commission for three reasons. First, the reason I bought a home in Emeryville is that it is a city that has embraced growth and development and meeting the needs for housing and commercial investments. I believe we are better as a community when we look forward, to our best days ahead, and ensure we are bringing all of our community along. That does not mean the pejorative "gentrification" - there are ways, if we are smart, deliberate, and careful, to enhance the community for current and future residents. Second, as someone with a progressive muscular disease, FSHD, I am keenly aware that I may not always be able to walk or bike around the City, so I want to make sure that we are encouraging accessible development. That balance is not always easy, but I think my voice can help find solutions. And third, I want to continue to bring my positive, solutions-based approach and prior experience and education to Emeryville, home.

## How do you think your unique lived experience will benefit or inform the Committee's recommendations?

As I mention, I have FHSD, a form of muscular dystrophy that means over time I am losing muscle strength and function in my face, arms and shoulders, hips and legs, and more. Some people with FSHD end up in a wheelchair and that could happen for me. I also live alone and plan to continue living in my home by myself. Those concerns are top of mind for me all the time, and can be challenging. I want to make sure we have a city that embraces all of our residents - where they are today, and where they could be in the future, for better or worse.

I believe deliberate, balanced planning decisions are essential to preserving our Emeryville, while embracing a future that is inclusive, equitable, and resilient. To maintain community diversity – including people with disabilities, like myself – we need to plan deliberately for affordability, access, and opportunity.

That means more housing of all types, from deeply affordable to market rate, so we can reduce displacement and support a range of incomes. I want us to move away from car-centered development – while acknowledging the value it brings for people with disabilities – and toward more accessible transit. And we should continue to embrace density, especially near transit corridors. That's not a sacrifice; it's how we build a city where people of all backgrounds and abilities can thrive. Emeryville has already become a hub for bioscience and is growing rapidly in healthcare, two sectors that provide high-wage, in-person jobs. We should actively support these industries, along with technology manufacturing and skilled trades. Not every great job requires a college degree, and our planning choices should reflect that. We've seen that office development alone is a risky bet in the current Bay Area market; diversifying the types of jobs we encourage is not just smart, it's necessary.

We must also manage traffic and infrastructure wisely, investing in bike, pedestrian, and transit improvements that connect people to homes and jobs without forcing them into a car. That's good planning for the climate, for affordability, and for equity.

With a background in urban management and public finance, and experience at the City of Phoenix, Moody's, and EBMUD, I bring both technical knowledge and lived experience to the role. An adage says, "If you're not at the table, you're on the menu." I'm interested in the Planning Commission to make sure everyone in Emeryville has a seat and is ready to eat.

## Why are you interested in serving on this Board, Commission or Committee?

I have been serving on this community';s boards for six years now, having lived in Emeryville for only four years and the East Bay for six at the time I started. As I have taken on more roles and deepened my understanding of this city';s built environment, a great deal of turnover has occurred in our city';s leadership. The City Council which first voted me onto the Housing Committee have all moved on. The Planning Commission has almost entirely turned over just since I joined it, as has the BPAC. Our City staff have also seen leadership changes from the top down, with those veteran employees who remain with us offering crucial continuity.

I would like to continue to serve in part because I have acquired relative seniority in my short time, and as such can offer some small continuity myself. But I have also put years of ongoing work into studying our community';s built environment at an intricate level and developing a vision for what it could be, just a little around the corner from our current planning documents. As we now consider developments of generational importance in Emeryville, I would like to continue to bring my perspective and do my part to help us be a proud city which is always ambitious in its pursuit of the public good.

## How do you think your unique lived experience will benefit or inform the Committee's recommendations?

I have lived a diverse and sometimes tenuous life, in places as different from each other as rural Montana and urban Hawaii. I am from Southern California but came back here to the Bay after a circuit of life experience that meant sometimes risking my life in a very real and palpable way commuting to work, and risking my life in a very theoretical and never-actualized way when I volunteered to serve the military while we were fighting two active wars. In the vast distances between these points, I have seen a lot.

But what I have seen that motivates me more than anything were the realities of growing up in poverty. Emeryville is a fine community full of good-hearted people, but only so many both have the opportunity to serve on these boards and share the experiences of the working poor we are surrounded by, and whose lives our decisions impact. The Emeryville I know is investing in a future where working class families have what they need to stabilize, thrive, and enjoy the community they live in. I aim to use my voice to continue that, because the places and ways that I have lived give me a deep appreciation for what we are and can be.

This city is riven, train tracks running through its center and a highway divorcing us from our water. Yet we are undeniably a coastal community — sometimes the winds remind you when the views don';t. We have no hills so all private windows are in competition with each other. Our city center has a gaping hole in the middle like a six-year-old';s smile, and much of the surrounding land was developed for an Emeryville of a somewhat more Offramp nature.

This is one of the finest places to build a city in California. But our challenges are very real. Over the past generation of work this city has grown its base of midrise housing, made radical new connections in active transportation infrastructure, and set us up to have the bike network this unique economy and place in the Bay Trail deserves.

We must be ambitious if we want to bridge the gap between what Emeryville already is — a great place to live and work — and what it can be: an iconic place to be and spend time, with robust connections between amenities and the waterfront, and fluid continuity within our central district. In the process of accomplishing these things we must continue to aggressively pursue the production of working class housing, especially as a jobs picture crystalizes which puts us in significantly greater housing debt. All these investments add up to a local community with priority access to amenities and public views that make us worth visiting.

That is the future I believe we have if we reach for it. An Emeryville where our neighbors spend their days, where people book rooms not because of what we are near but what we are. And one in which our own community is all the more connected in the process.
