Hi Daniel,

Thanks for getting back to me so quickly and for sharing the key points from your correspondence with Alyssa about the bikeshare station. To clarify, I believe the part she said she hadn't heard back on yet was the plan itself that was sent over (just on Monday apparently, so it's not surprising you hadn't had a chance to respond yet). Seems like that's taken care of now though! I'm very glad to hear that you've reviewed the plan and don't have any operational concerns about it based on a thorough technical analysis.

However, I do wonder if you'd be willing to share this rationale at the board meeting, perhaps just as a brief informational item? As a new member of the ETMA Board, I'd be interested in the opportunity to learn more about how our bus stops work. And as a former member of the Bicycle and Pedestrian Advisory Committee, I'm also very interested in the integration of our bike/ped and transit networks into a truly multimodal transportation system.

Hi Brooks,

I think their may have been some misunderstanding in Alyssa's statement. She and I have had multiple correspondence about this particular bike station. Here is a breakdown of the information and requirements we gave to her:

- The bus stop begins at the stop sign, right before the crosswalk: 37.837023, -122.304686
- The longest bus we have is 46ft in length
- We need 14ft of clearance to safely and fully pull into the stop
- We conveyed to Alyssa on April 23<sup>rd</sup> that we need a minimum of 60ft from the stop sign to remain clear
- Based on the plan she sent me on Monday they will be adhering to the 60ft requirement

Hi Daniel, Janet, and Bobby,

I was wondering if I could request adding an item to the agenda for our board meeting next week?

At the City's Transportation and Sustainability Committee meeting today, staff proposed a new bikeshare station on Powell at Commodore next to the Emery Go-Round stop. One the one hand, the siting of a bike station in close proximity to a transit stop has undeniable advantages from a TDM perspective. However, the proposed design appeared to significantly reduce the size of the current stop zone (apparently by as much as 36 feet), which could potentially affect the ability of our operators to safely pull into and out of that stop (particularly if it is also to be used for carpooling).

The staff member who presented this item at the meeting, Alyssa Chung (copied here), mentioned that she had already reached out to Altrans for input on the proposal, but had not yet heard back. The matter is of some urgency though because the proposal was approved by the committee today and will go to City Council soon in a couple weeks. So there is only a narrow window for us to weigh in and I was wondering if we could fit it onto the agenda for next week so that the Board has a chance to discuss and comment on the City's proposal before it goes to Council?
