Resolution Of The City Council Of The City Of Emeryville Accepting The MacArthur Boulevard Full Trash Capture Project, (CIP Project No. 18475009), As Complete And Authorizing The City Engineer To File A Notice Of Completion With The Alameda County Clerk

**WHEREAS**, the MacArthur Boulevard Full Trash Capture Project is a Capital Improvement Program project (CIP No. 18475009), involving the installation of a hydrodynamic trash separator in the storm drain line; and

**WHEREAS**, the City of Emeryville is subject to stormwater regulations covering removal of trash and pollutants defined in the San Francisco Regional Water Quality Control Board's (RWQCB) Municipal Regional National Pollutant Discharge Elimination System Permit (MRP 3.0, Order No. R2-2022-0018); and

**WHEREAS,** as a condition of the MRP, all permittees are required to reduce, by July 2025, the amount of trash discharging from their storm drain system by 100% from baseline levels established in 2009; and

**WHEREAS**, on June 15, 2021, the City Council unanimously adopted Resolution No. 21-67 authorizing the City Manager to accept \$680,000 in Cooperative Implementation Agreement funding from Caltrans towards this project, and, on July 5, 2022, the City Council adopted Resolution No. 22-90 authorizing the City Engineer to advertise for public bids for the project; and

**WHEREAS**, the project construction contract was advertised on September 6, 2022, and the bids were opened on September 27, 2022. A total of six (6) bids were submitted and received by the City; and

WHEREAS, the project was substantially completed in May 2023; and

**WHEREAS**, the project is complete and ready for acceptance by the City Council and the City Engineer must now file a Notice of Completion with the Alameda County Clerk; now, therefore, be it

**RESOLVED**, by the City Council of the City of Emeryville, the City hereby accepts the MacArthur Boulevard Full Trash Capture Project (CIP No. 18475009) as complete and authorizes the City Engineer to file a Notice of Completion with the Alameda County Clerk.
