WHEREAS, the City of Emeryville is committed to expanding and enhancing its urban tree canopy as part of its Climate Action Plan and environmental sustainability initiatives to improve air quality, reduce urban heat island effects, provide habitat for wildlife, enhance the visual environment, and promote the health and well-being of residents; and

WHEREAS, unprecedented weather conditions in 2023 caused significant damage to Emeryville's urban forest, resulting in the loss of approximately 100 mature trees in Marina Park; and

WHEREAS, tree canopy expansion supports the City's goals for climate resilience, environmental sustainability, and community health; and

WHEREAS, on June 18, 2025, five bids were received for the project with the lowest responsive bid submitted from Los Loza, Inc. for \$712,130 which was \$67,870 below the engineer's estimate of \$780,000; and

WHEREAS, sufficient funding is available in the Capital Improvement Program project URG-04, "Urban Tree Planting Program," project 24251004; and; now, therefore, be it

WHEREAS, this project is exempt from the California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines Section 15301(c); now, therefore, be it

RESOLVED, by the City Council of the City of Emeryville that the City Manager is authorized to enter into a contract with Los Loza Inc. in the amount of \$712,130.00, and, be it, further

RESOLVED, by the City Council of the City of Emeryville that the City Manager is authorized to increase the contract by \$177,870.00 for a total not to exceed contract amount of \$890,000;
