FIRST AMENDMENT

THIS FIRST AMENDMENT TO THE MAINTENANCE SERVICES CONTRACT ("Amendment") is effective as of ____04/07/2023 _____ by and between THE CITY OF EMERYVILLE, a municipal corporation, ("City") and DC ELECTRIC GROUP, INC. ("Contractor"), individually referred to as a "Party" and collectively as the "Parties".

WITNESSETH THAT

WHEREAS, the City and Contractor entered into a Maintenance Services Contract dated December 30, 2020 ("Contract") for the purpose of retaining the services of Contractor to provide on-call traffic signal and streetlight maintenance; and

WHEREAS, the City and Contractor desire to amend the Contract; and

WHEREAS, the public interest will be served by this Amendment.

NOW, THEREFORE, the Parties hereto do mutually agree as follows:

1. AMENDMENT

The Parties agree to amend the Contract as checked below:

1.1 Exhibit A

Exhibit A of the Contract is hereby amended in its entirety and replaced with **Exhibit A-**Revision Number;

OR

Exhibit A of the Contract is hereby amended to include the provisions of **Exhibit A-1**, attached hereto and incorporated herein by this reference.

1.2 Termination Date

1.3 Total Compensation Amount

The Parties desire to increase the Total Compensation Amount as set forth in Section 1.3.C of the Contract by EIGHT HUNDRED EIGHTY ONE THOUSAND THREE HUNDRED TEN DOLLARS AND NO CENTS (\$881,310.00). The total amount paid under the Contract as compensation for Services performed and reimbursement for costs incurred shall not, in any case, exceed ONE MILLION FIVE HUNDRED FIVE THOUSAND ONE HUNDRED FORTY FIVE DOLLARS AND NO CENTS (\$1,505,145.00).

2. CONTINUING EFFECT OF CONTRACT

Except as amended by this Amendment, all other provisions of the Contract remain in full force and effect and shall govern the actions of the Parties under this Amendment. From and after the date of this Amendment, whenever the term "Contract" appears in the Contract, it shall mean the Contract as amended by this Amendment.

3. ADEQUATE CONSIDERATION

The Parties hereto irrevocably stipulate and agree that they have each received adequate and independent consideration for the performance of the obligations they have undertaken pursuant to this Amendment.

4. SEVERABILITY

If any portion of this Amendment is declared invalid, illegal, or otherwise unenforceable by a court of competent jurisdiction, the remaining provisions shall continue in full force and effect.

5. WAIVER

The City's failure to enforce any provision of this Amendment or the waiver in a particular instance shall not be construed as a general waiver of any future breach or default.

1. Greenway Trail Counter Installation/Repairs

Scope of Work:

• Furnish and install replacement parts and troubleshoot as needed to activate the system

Scope of Work:

- Remove existing legacy camera systems from (8) intersections on Hollis St
- Furnish and install new Vision camera systems for all approaches at (8) intersections
- Configure cameras for passive pedestrian detection and connect to City traffic network for remote operation

6. GIS Survey of Electrical Infrastructure for USA Tickets

- Compile mapping and attribute data into files compatible with City GIS system
- 29 Traffic Signals (per intersection cost = \$1,000)
- 1845 Streetlights (per SL cost = \$60.00)

7. Temescal Creek Park - Light Pole Installation and Dog Park Drain Repair

Scope of Work:

- Intercept existing lighting conduit, trench approximately 200' around back side of park and install new 1" conduit
- Dig and pour 3 new pole foundations and install all necessary pull boxes, wiring, fuses etc. to connect to existing lighting circuits
- Furnish and install 3 new light poles and LED fixtures to match existing
- Dig out existing drain rock and aggregate surface and clear drain
- Install clean-out and aggregate barrier to minimize future blockage
- Re-install cleaned drain rock and aggregate surface
