Resolution Of The City Council Of The City Of Emeryville Authorizing The City Manager To Purchase One Pump And One Woodchipper Through A Sourcewell Awarded Contract, A Cooperative Purchasing Agreement, For A Total Amount Not To Exceed \$141,387 For Emergency Response To Severe Climate-Related Events And Ongoing And Regular Needs

**WHEREAS**, the City entered into a Membership Contract (Cooperative Purchasing Agreement) with Sourcewell. (Contractor) on May 10, 2019; and

**WHEREAS**, under the Sourcewell Agreement, Contractors are determined and approved under a Cooperative Purchasing Agreement; and

**WHEREAS**, the City needs to own equipment, rather than depend on renting equipment due to unforeseen climate related events where rental equipment may become scarce; and

**WHEREAS**, the funds spent for the purchase of this equipment is equivalent to renting the equipment for 16 months for the pump, and 17 months for the woodchipper; and

**WHEREAS**, the City is exempt from undertaking a formal bid process for the purchase of this equipment if the City "piggybacks" on another state agency's bid process such as Sourcewell's Cooperative Purchasing Agreement with the State of California; and

**WHEREAS**, there are sufficient funds in the unallocated Marina Fund 495 balance, Storm Water Management CIP# ESI-01, and General Maintenance Program CIP# FM-01 to purchase this equipment; therefore be it

**RESOLVED**, by the City Council of the City of Emeryville that the City Manager is authorized to purchase one pump and one woodchipper under Sourcewell's Cooperative Purchasing Agreement for a Total Amount Not to Exceed amount of \$141,387, with appropriations of \$113,109 from the unallocated fund balance of the Marina Fund 495, \$14,139 from the Storm Water Management CIP#ESI-01, and \$14,139 from the General Maintenance fund CIP program #FM-01.
