Anderson, Beverley – Claim Against The City of Emeryville (cont.)

What did the entity or employee do to cause this loss, damage, or injury?

On May 30, 2025, at approximately 2:30 P.M., Beverley Anderson was walking on the sidewalk located at or adjacent to the north side of 1300 55th Street., Emeryville, CA 94608. At the same time, there was an exposed metal object protruding from the same sidewalk. Ms. Anderson was walking on the sidewalk when she momentarily stepped to her right – while remaining on the sidewalk - to make room for oncoming foot traffic. Once the oncoming foot traffic cleared, she proceeded to continue walking when suddenly, and without warning, she tripped over the metal object protruding from the sidewalk, causing her serious bodily injuries. On information and belief, The City of Emeryville owned, controlled, and/or was responsible for maintaining the sidewalk. The entity who owned and/or controlled the sidewalk negligently failed to routinely inspect and maintain the area so as to eliminate the existence of dangerous conditions to pedestrians, including Ms. Anderson. The defendant's negligence and lack of due care ultimately created the hazardous conditions that directly resulted in Ms. Anderson's injuries. Please see the attached photos of the subject location and the metal object surfacing from the subject sidewalk.

What specific injuries, damages, or losses did claimant receive?

The full scope of Ms. Anderson's injuries is unknown; however, as of this time, Ms. Anderson sustained the following injuries: broken right foot and groin injury.
