Resolution Of The City Council Of The City Of Emeryville Approving Addition Of New Scope Of Work (Exhibit A-1) Related To Additional Design Work For Unsignalized Intersections On The North Side Of 40th Street As Part Of The 40th Street Multimodal Project For The Professional Services Contract With Diablo Engineering Group

WHEREAS, on March 3, 2020, the City Council approved the conceptual design of the 40th Street Multimodal Project and found it to be exempt from the California Environmental Quality Act; and

WHEREAS, as part of the resolution, City Council instructed Staff to conduct a traffic feasibility study for full and partial closures of the unsignalized streets that connect to 40th Street from the north (Watts, Haven, Holden, and Hubbard); and

WHEREAS, in August 2022, the Public Works Department issued a Request for Proposals for "Professional Design Services for the 40th Street Transit-Only Lanes And Multimodal Enhancements Project" and after careful evaluation, City staff identified Diablo Engineering Group ("Diablo Engineering") as the most suitable consultant, considering their approach, experience, and understanding of the City's requirements; and

WHEREAS, in early 2023, Fehr & Peers (a subconsultant to the Diablo Engineering team) completed a traffic feasibility analysis as one of the first items of work for the design phase of the Project and the results of the analysis were shared with the Emeryville Transportation Committee on May 9, 2023; and

WHEREAS, there is need for additional work related to the unsignalized intersections, Staff recommends extending the design contract with Diablo Engineering to include Exhibit A-1 for a total cost of \$120,232.00; and

WHEREAS, Tasks described in Exhibit A-1 include the preparation of final traffic analyses, environmental studies, and civil designs for the additional design work needed for the unsignalized intersections on the north side of 40th Street; and

WHEREAS, the 40th Street Multimodal Project including Exhibit A-1 is fully funded through various grant programs for Design and Construction Phases, and there is adequate budget in CIP Project No. 22242002; now, therefore, be it

RESOLVED, by the City Council of the City of Emeryville that the City Council approves the addition of new scope of work (Exhibit A-1) related to additional design work for unsignalized intersections on the north side of 40th Street as part of The 40th Street Multimodal Project for the Professional Services Contract With Diablo Engineering Group.

Exhibit A-1 – Design Work for Unsignalized Intersections on 40th Street (Task 8)



SCOPE OF WORK - PHASE 1

The Diablo Team will collaborate with the City Team to implement the following design and coordination items for the Project.



Project Tasks

- 8. 40th Street Phase 1 Added Scope of Work
 - **8.1. Video Data Collection:** For Hubbard Street, Horton Street, Holden Street, and Watts Street (between 40th Street and Park Avenue, IDAX to obtain 24-hour video for 4 weeks and then processing 12 hours per day for the first 14 days, given that the nighttime will likely have little activity. All videos will be collected using strategically placed wide angle timelapse cameras to cover the curb space. Full video will be provided in addition to a summary of Delivery Truck, Single Unit Truck and Truck w/Trailer per road and by date.
 - **8.2.** Added Traffic Analysis for Horton Diverter and Chick-Fil-A: For Hubbard Street, Holden Street, Haven Street and Watts Street, the traffic analysis includes all of these streets either opened or fully closed. In the original Alternative 2, the Horton Diverter was added to the analysis as requested by the City. After further coordination, the decision on if the Horton Diverter will be installed has been postponed until after this project. The City has also brought up concerns about the heavy traffic caused by the new Chick-Fil-A restaurant. Therefore, the following tasks will be added to the traffic analysis:
 - Collect traffic data for Chick-Fil-A.
 - Update Alternative 1 (all streets open) with Chick-Fil-A data.
 - Add New Alternative 3 (unsignalized streets closed, no Horton Diverter) with Chick-Fil-A data.
 - Prepare the final operations report with updated analysis.
 - Exclude Alternative 2 from any further analysis and exclude it from the final report.
 - **8.3** Added Field Topography for Hubbard Street: For Hubbard Street sidewalk on the West side, topography will be collected to be used for designing new sidewalk to close the gap between 40th Street and Park Boulevard.
 - **8.4** Added Design for Hubbard St and Path Connection to Halleck St: For Hubbard Street sidewalk on the West side, design of new sidewalk (approximately 320 linear feet) to close the gap between 40th Street and Park Boulevard will be added to the 40th Street plan submittals. In addition, a new Class I path (approximately 280 linear feet) will be added to connect Halleck Street to the new cycle track on 40th Street in the area of Hubbard Street. This design will involve tight grading and potentially retaining walls given the constraints between 40th Street and the Pottery & Beyond lot. This will also be added to the 40th Street plan submittals.
 - **8.5** Additional Outreach Efforts: <u>Unsignalized Intersection Outreach</u>: Effort for the preparation and mailing of the mailer to these stakeholders has gone through additional rounds of review which has increased labor cost. The area the mailer is being sent to has increased the number of mailings, currently estimated to be 550.









<u>Postcard to Broader Area around 40th Street project:</u> This is a new task requiring content development and layout for the postcard to inform a broader area of stakeholders about the project moving forward and the Council Meeting where the 35% design will be approved. Printing and mailing costs of the postcard is based on an estimated 750 addresses.
