

RESOLUTION NO. 24-

Resolution Of The City Council Of The City Of Emeryville Approving And Adopting A Memorandum Of Understanding With The Confidential Administrative Managerial (CAMP) Professional Authorizing The City Manager To Execute The Memorandum Of Understanding And Approving An Amendment To The City's Classification And Compensation Plan In Conformance With California Code Of Regulations, Title 2, Section 570.5

WHEREAS, the current Memorandum of Understanding between the City of Emeryville (the "City") and Confidential Administrative Managerial Professional ("CAMP") expired June 2022; and

WHEREAS, the City and CAMP entered into negotiations for a successor memorandum of understanding; and

WHEREAS, pursuant to the provisions of the Meyers-Milias-Brown Act (Government Code Section 3500, *et seq.*) and the Emeryville Employer-Employee Organizational Relations Resolution (Resolution No. 86-05), the City Manager or designee, as authorized by the City Council, has met and conferred in good faith with the representatives of CAMP on matters related to wages, hours, and other terms and conditions of employment; and

WHEREAS, the representatives of the City and CAMP have reached a tentative agreement to a successor Memorandum of Understanding (the "MOU"), attached hereto and incorporated herein by this reference as Exhibit A; and

WHEREAS, the membership of CAMP ratified the agreement as of February 27, 2024; and

WHEREAS, the City Council finds that the terms and conditions of the MOU are proper and in the best interests of the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Emeryville hereby approves and adopts the MOU for CAMP, effective July 1, 2023 and authorizes the City Manager to execute the MOU and to take such further actions as may be necessary to implement the MOU including any necessary non-substantive modifications.

BE IT FURTHER RESOLVED that if any provisions related to the MOU contained herein are found to be in conflict with provisions of any other previous resolutions related to the MOU, the provisions herein shall prevail.
