Resolution Of The City Council Of The City Of Emeryville Authorizing The City Manager To Enter Into A Cooperative Agreement With The Alameda County Fire Department For The Purchase And Installation Of The Phoenix G2 Fire Station Alerting System At City Fire Stations, In An Amount Not To Exceed Two Hundred And Seventeen Thousand Four Hundred And Ninety-Nine Dollars And Eighty Two Cents \$217,499.82 For The Project, Appropriating Eighty-Six Thousand Dollars And Authorizing The City Manager To Increase The Agreement Amount By \$86,000 From The General Capital Improvement Fund 475 To Project 24475015

**WHEREAS**, the Alameda County Fire Department ("ACFD") provides contract fire and emergency response services within the incorporated limits of the City of Emeryville ("City") pursuant to an existing Services Contract; and

**WHEREAS**, the alerting equipment currently installed at City Fire Station 34 (2333 Powell Street) and Fire Station 35 (6303 Hollis Street) has reached the end of its service life and requires replacement; and

**WHEREAS**, installation of the modern, network-based Phoenix G2 Fire Station Alerting System ("Alerting System") will improve emergency response times and enhance firefighter safety; and

**WHEREAS**, ACFD and the City have negotiated a Cooperative Agreement attached hereto as Exhibit A ("Agreement") under which ACFD will procure, manage and install the Alerting System, and the City will reimburse ACFD for the actual project cost in an amount not to exceed \$217,499.82; and

**WHEREAS**, \$161,500 in funding for the Alerting System is available in the Capital Improvement Program, CIP #ESI-05 Project Number "Fire Station Alert System", and appropriating an additional \$55,999.82 and \$30,000 to cover unforeseen work from the unassigned fund balance within the General Capital Fund #475; and

**WHEREAS**, the City Council desires to authorize execution of the Agreement and appropriation of the necessary funds; now, therefore, be it

**RESOLVED**, by the City Council of the City of Emeryville that the City Manager is hereby authorized to execute the Cooperative Agreement in substantial form to Exhibit A and to expend an amount not to exceed \$217,499.82 for the purchase and installation of the Alerting System, and appropriating \$86,000 from the General Capital Improvement Fund 475 to Project 24475015.
