

RESOLUTION NO. 22-05

Resolution Of The City Council Of The City Of Emeryville Approving The Scope Of Work For And Authorizing The City Engineer To Advertise For Public Bids The Construction Of The Annual Street Rehabilitation And Preventive Maintenance Project Fiscal Year 2021/2022, Project No. EPW-21102 (CIP No. 17240005); CEQA Determination: Exempt Pursuant to CEQA Guideline 15301(c)

WHEREAS, the Capital Improvement Program adopted by the City Council in June 2019 and the Budget adopted by the City Council in June 2021 includes funding for the ongoing Annual Street Rehabilitation/Preventive Maintenance Program, CIP No. 17240005 (the "Project"); and

WHEREAS, rehabilitation and maintenance work on public streets need to be coordinated with other City projects, utility company excavations and private development projects on a cycle that sustains a high Pavement Condition Index (PCI) for all City streets; and

WHEREAS, the streets to be rehabilitated were identified as needing rehabilitation in the Pavement Management Program Budget report prepared as part of MTC's Technical Assistance Program P-TAP in February 2020; and

WHEREAS, the project includes work on the following streets

- 41st Street (San Pablo Avenue – Adeline)
- 43rd Street (San Pablo Avenue – Adeline)
- 45th Street (San Pablo Avenue – Adeline)
- 47th Street (San Pablo Avenue – Adeline)
- 48th Street (San Pablo Avenue – City Limits)
- Salem Street (43rd Street – 45th Street)
- Essex Street (43rd Street – 45th Street)
- Doyle Street (45th Street – Steve Dain Drive)
- Steve Dain Drive (Doyle Street – San Pablo Avenue); and

WHEREAS, Crossroad Lab has been retained by the City as part of an on-call contract to provide active transportation design services for the PS&E (Plans, Specifications, and Estimate) while City Staff is preparing the Civil Improvements plans which includes hardscape concrete construction items and identified areas for pavement rehabilitation; and

WHEREAS, the PS&E package will be substantially complete January 2022 and ready for bidding in February 2022; and

WHEREAS, there is adequate budget in CIP Project No. 17240005 to complete the project; and

WHEREAS, once the City Engineer has reviewed and approved the plans and specifications they will be ready to advertise for Public Bids; now, therefore, be it




