## Resolution Of The City Council Of The City Of Emeryville Authorizing The Chief Of Police To Issue An Annual Cabaret License To Trader Vic's For Calendar Year 2022

**WHEREAS**, Emeryville Municipal Code 5-30.03 provides that a license is required to operate a cabaret in the City of Emeryville; and

**WHEREAS**, an applicant for a cabaret license is required to submit an application to the Police Department; and

**WHEREAS,** Trader Vic's has submitted an application for an annual cabaret license for calendar year 2022 to the Emeryville Police Department; and

**WHEREAS**, the Chief of Police has conducted an investigation of Trader Vic's application and has prepared a report and recommendation as required by the Emeryville Municipal Code; and

**WHEREAS**, the Chief of Police has recommended the application be approved and an Annual Cabaret License issued subject to conditions of approval; and

**WHEREAS,** it can be seen with certainty that issuance of an Annual Cabaret License to Trader Vic's will have no possibility of having a significant effect on the environment and therefore said issuance is exempt from review under the California Environmental Quality Act; and

**WHEREAS**, the City Council held a public hearing on February 1, 2022, to consider the application, the report and recommendations by the Chief of Police, and the comments received from the public regarding the application; now, therefore, be it

**RESOLVED**, pursuant to Emeryville Municipal Code Section 5-4.07, the City Council of the City of Emeryville finds that the above recitals are true and correct and are incorporated herein, and hereby approves an annual cabaret license for calendar year 2022 to Trader Vic's, subject to the Conditions of Approval, attached hereto as Exhibit A, and authorizes the Chief of Police to issue said license.

## EXHIBIT A

## CONDITIONS OF APPROVAL

- The Annual Cabaret License would be valid through to December 31, 2022. Any Annual Cabaret License sought for subsequent years would require another application and an approval by the Emeryville City Council.
- The Annual Cabaret License permits music to be played inside Trader Vic's, 9 Anchor Dr. Emeryville, CA 94608. and not on the exterior patio. Trader Vic's is also seeking approval of to utilize their parking lot for special events, one being August 29, 2022. During this event Trader Vic's plans to have live music performed, dinner served and alcoholic beverages provided in the parking lot. This will only commence upon the approval of a TUP from the City of Emeryville. Each separate event in addition to the one noted above on August 29, 2022 will require the approval of a TUP from the City of Emeryville.
- All exterior doors and windows will be closed for the designated date and times of each cabaret event when held indoors.
- Upon receipt of a noise complaint from any adjacent or neighboring properties during any cabaret event at Trader Vic's, Trader Vic's will immediately discontinue all music.
- Hours of operation for this Annual Cabaret License would be restricted to Wednesday through Sunday, 12:00 PM to 9:00 PM.
- Trader Vic's shall be required to designate a contact person from Trader Vic's for all complaints from the public and to interface with the Emeryville Police Department. This contact person shall be made known to the Emeryville Police Department and all complaining parties upon request. The contact person shall be immediately available for all concerns or complaints.
- Any violations of these conditions or any listed in Emeryville Municipal Code 5-4.24 by Trader Vic's owners, managers, or employees may result in suspension or revocation of this Annual Cabaret License, pursuant to Emeryville Municipal Code Sections 5-4.08, 5-4.09.
