Resolution Of The City Council Of The City Of Emeryville Authorizing The Chief Of Police To Issue An Annual Cabaret License To The Bureau Of Emeryville, LLC dba The Bureau 510 For Calendar Year 2022

WHEREAS, Emeryville Municipal Code 5-4.03 provides that a license is required to operate a cabaret in the City of Emeryville; and

WHEREAS, an applicant for an Annual Cabaret License is required to submit an application to the Police Department; and

WHEREAS, The Bureau of Emeryville, LLC dba The Bureau 510 has submitted an application for an Annual Cabaret License for calendar year 2022 to the Emeryville Police Department; and

WHEREAS, the Chief of Police has conducted an investigation of The Bureau of Emeryville, LLC dba The Bureau 510 application and has prepared a report and recommendation as required by the Emeryville Municipal Code; and

WHEREAS, the Chief of Police has recommended the application be approved and an Annual Cabaret License issued subject to conditions of approval; and

WHEREAS, the City Council held a public hearing on September 6, 2022, to consider the application, the report and recommendations by the Chief of Police, and the comments received from the public regarding the application; now, therefore, be it

RESOLVED, by the City Council of the City of Emeryville that, pursuant to Emeryville Municipal Code Section 5-4.07, the City Council of the City of Emeryville hereby approves an Annual Cabaret License for calendar 2022 to The Bureau of Emeryville, LLC, dba The Bureau 510 subject to the Conditions of Approval, attached hereto as Exhibit A, and authorizes the Chief of Police to issue said license.

EXHIBIT A

CONDITIONS OF APPROVAL

- The Annual Cabaret License would be valid through to December 31, 2022. Any Annual Cabaret License sought for subsequent years would require another application and an approval by the Emeryville City Council.
- The Annual Cabaret License if approved permits The Bureau of Emeryville, LLC dba The Bureau 510 to hold periodic fashion shows inside the business, every 2-3 months, starting on September 29th, 2022 and, in addition to the fashion shows, the playing of live music within the business and patio area once a week.
- Upon receipt of noise complaints during any cabaret event at The Bureau of Emeryville, LLC dba The Bureau 510, The Bureau of Emeryville, LLC dba The Bureau 510 will immediately discontinue the event and all music.
- Hours of operation for this Annual Cabaret License would be restricted to Monday through Sunday, 6:00 PM to 8:00 PM for the fashion shows and Monday through Sunday, 5:00 PM to 7:00 PM for the live music.
- The Bureau of Emeryville, LLC dba The Bureau 510 shall be required to designate a contact person from The Bureau of Emeryville, LLC dba The Bureau 510 for all complaints from the public and to interface with the Emeryville Police Department. This contact person shall be made known to the Emeryville Police Department and all complaining parties upon request. The contact person shall be immediately available for all concerns or complaints.
- Any violations of these conditions or any listed in Emeryville Municipal Code 5-4.24 by The Bureau of Emeryville, LLC dba The Bureau 510 owners, managers, or employees may result in suspension or revocation of this Annual Cabaret License, pursuant to Emeryville Municipal Code Sections 5-4.08, 5-4.09.
