

Emeryville Client Outcomes Winter Shelter 2015/2016

The 2015-2016 Winter Shelter provided 20 unduplicated individuals who were homeless and from Emeryville with 688 shelter bed nights.

Core Elements:

- Shelter beds were prioritized to those participants identified to be Oakland and Emeryville residents.
- Winter shelter beds were accessible to clients through a referral process and included 5 beds allocated to Berkeley Food and Housing Program (BFHP) as the City of Emeryville's outreach grantee.
- Walk-up beds were available to ensure access to the winter shelter for those not engaged with the referring providers as well as to ensure that no beds were left empty when possible.
- The City Of Oakland implemented a broad definition of 'homeless residents from Emeryville' which included : did they lose their housing in Emeryville, did they sleep in Emeryville last night, do they frequently spend the day in Emeryville, do they work or go to school in Emeryville, etc. in order to best capture the total number of unduplicated Emeryville homeless served.
- Saint Vincent de Paul (SVDP) Winter Shelter staff administered a residential screener to all incoming winter shelter clients.
- Anyone identified as an Emeryville resident per the screener described above was referred to BFHP for services.

Preliminary Outcomes:

- SVDP was the sole agency entering data into HMIS for Winter Shelter. Best efforts were made to ensure complete, accurate, and timely entry and exit data was entered. The following are the exit outcomes for Winter Shelter client population as a whole from HMIS APR.
 - 21 clients exited to permanent destinations (rental with or without subsidy, PSH, Permanently living with family, etc.).
 - 61 clients exited to temporary destinations (emergency shelter, transitional housing, hotel/motel, etc.).
- Seasonal overall occupancy rate: 80.5%
- Total number of Bed nights available: 9670
- Bed nights used (duplicated clients): 7748 and of those;
 - 7038 bed nights were used by Oakland residents
 - 688 bed nights were used by Emeryville residents
 - 14 bed nights were used by out of area residents

Total number of unduplicated clients served:

- 253 and of those
- 20 unduplicated Emeryville clients
