Resolution Of The City Council Of The City Of Emeryville Awarding and Authorizing The City Manager To Enter Into A Contract With DC Electric Inc. In An Amount Not To Exceed \$193,928 For The Construction Of The Lumec Streetlight LED Retrofit Project, EPW 106-16 (CIP #15475015).

**WHEREAS**, the Capital Improvement Program adopted by the City Council in June 2016 includes funding for the Lumec Streetlight Pole Painting and LED Retrofit, CIP No. 15475015; and

**WHEREAS,** to increase quality control and efficient management of the CIP No. 15475015, the LED retrofit of the streetlights will be performed as a separate construction project prior to the painting of the poles ("Project"); and

WHEREAS, the Project includes upgrading to Lumec streetlights throughout the City of Emeryville from the existing 100 and 175 metal halide fixtures to 65 watt LED fixtures; and

WHEREAS, the LED fixtures use a more energy efficient lamp than the existing metal halide fixtures, have a much longer lamp life and do not require replacement of failed ballasts, thereby reducing annual maintenance and energy costs; and

**WHEREAS,** on September 6, 2016 City Council authorized the City Manager to purchase the Lumec materials from Independent Utility Supply of Tracy, California in an amount not to exceed \$982,930.04 to supply to the contractor for the Project; and

WHEREAS, on September 6, 2016 the City Council approved the project concept plans for the Lumec Streetlight LED Retrofit Project, EPW 106-16 (CIP #15475015) and authorized the City Engineer to advertise the project for public bids; and

**WHEREAS**, the Project was bid on December 12, 2016, in compliance with California Public Contract Code section 20162, et seg.; and

WHEREAS, on January 10, 2017, six bids for the Project were received; and

**WHEREAS**, the lowest responsible bid for the Project was submitted by DC Electric of Cotati, CA for \$193,928, which includes a contingency of \$10,000; and

**WHEREAS,** there is \$2,025,000 in funds allocated in the Lumec Streetlight Pole Panting and LED Retrofit Project, EPW 106-16 (CIP #15475015) and this amount is sufficient to cover the anticipated cost of the Project; now, therefore, be it

**RESOLVED**, that based on the foregoing recitals, the City Council of the City of Emeryville hereby awards the construction contract for the Project to DC Electric of Cotati, CA, and authorizes the City Manager to execute a contract with DC Electric Inc. in an amount not to exceed \$193,928 for the Lumec Streetlight LED Retrofit Project, (CIP# 15475015).
