BPAC Committee Application

1. Work History & Education:

Work: I have worked as a paralegal for the past 20 years. In my current job, which I have been at for about 5 years, I work with a team of lawyers on complex litigation involving a wide variety of issues. Additional duties currently include tracking insurance and financial information on almost 300 cases for another team of attorneys. I also ran my own arts business for 18 years. In addition to the creative work, I gained skills in negotiation, administration, and handling legal and regulatory paperwork relating to my business and, above all, being able to pick up new skills as needed.

2. Past involvement with Emeryville:

My involvement with the City of Emeryville has taken the form of attending and speaking at meetings of the City Council, Planning Commission and General Planning workshops. I have been involved in neighborhood issues, including meetings with developers of nearby projects. I have volunteered to staff one of Emeryville's energizer stations on Bike to Work Day for I have attended a few BPAC meetings. A conflict with my work hours and the very limited time for public comment have lead me to voice my concerns and comments about biking issues directly to Peter Schultz-Allen or to other members of the committee. 3. My interest in this committee:

On Bike to Work Day this year, I had a chance to look through Emeryville's long-term bike plan. I was impressed by how many of the recommended improvements have been completed. I would like to see Emeryville continue to plan and implement improvements for cyclists and pedestrians and I would love to be part of that process. In addition to the exciting projects currently in the works for new bike/ped bridges at 53rd and 65th Streets, I would like to see the City plan bike routes that create cross-town connections and close some of the gaps in the current network of bike lanes. In addition, I think there are a number of actions that could be taken quickly and with minimal expenditure that would improve the lives of cyclists and walkers, such as fixing the cycles at certain traffic signals and painting bike insignia on loop sensors so cyclists know where to stop to trigger traffic signals. I would also like to see

more public involvement with the Bike-Ped Committee. I would be interested in organizing events to get input from Emeryville residents and from people who commute here by bike (or would like to) to find out what's working for them and what improvements would help them get out of their cars.
