**WHEREAS**, the purpose of the Maddy Act is to encourage and support the opportunity for all citizens to participate in, and contribute to, the operations of their local government by serving on such Advisory Bodies; and

**WHEREAS**, all Advisory Bodies appointed by the City Council of the City of Emeryville, and the qualifications/eligibility requirements for each position on those Advisory Bodies, are listed in the Local Roster maintained by the City Clerk; and

**WHEREAS**, the City Clerk desires to amend the regular meeting schedule of the Budget Advisory Committee to meet on the second Thursday of February, May, October and December; and

WHEREAS, the City Clerk desires to amend the regular meeting schedule of the Budget and Governance Committee to meet on the second Thursday of February, May, October and December; and

WHEREAS, the City Clerk desires to amend the regular meeting location of the Community Services Committee to convene at the Emeryville Center of Community Life, located at 4727 San Pablo Avenue, Emeryville, California; and
