## **Accessory Dwelling Unit Study**

## Detached, with 6-foot setback from main house

Some statistics about the Medium Density Residential (RM) Zone in Emeryville:

441	parcels in the RM Zone contain residences.
113	parcels (26%) contain single-family homes.
64	parcels (57% of single-family homes) have at least 300 square feet of space to construct an ADU in the backyard, given the required rear and side setbacks, and assuming the minimum distance from the main house of <b>six</b> feet.
42	of the 64 parcels above (37% of single-family homes) are owner-occupied.

Potential ADU footprints for the 42 parcels described above:


**Table 1.** Parcel Coverage for the RM Zone


40%	Average parcel coverage for the RM Zone.
38%	Average parcel coverage for single family homes.
33%	Average parcel coverage for the 42 owner-occupied single-family homes described above, with no ADU.
54%	Average parcel coverage for the above 42 parcels if each built the largest possible ADU for their lot, up to 1200 square feet, given the required setbacks and assuming six feet distance from the main house.
46%	Average parcel coverage for all parcels with single family homes, if all 42 of the above parcels built the largest possible ADU for their lot.
41%	Average parcel coverage for RM Zone with the addition of 42 ADUs.

**Table 2.** Estimated maximum backyard areas, given required rear (5 feet) and side (3 feet) setbacks, and 6 feet distance from the main house. Please note that for the backyards larger than 1200 square feet, the maximum of 1200 was added to the original Footprint Area in the column "Footprint Plus ADU," below. For purposes of this analysis, "backyard area" does not include area within setbacks.

Parcel Coverage was compared to potential ADU size for the 42 owner-occupied single family homes which could construct a new ADU.

Generally, potential ADU size was inversely related to parcel coverage. Where that varied, house placement on lots and/or existing setbacks and separation requirements limited ADU size.

None of the parcels which could build the largest possible ADU (1,200 square feet) had existing parcel coverage greater than 40%. The average for these 14 parcels was 28% (range of 19 - 37% parcel coverage).
