Helping the City navigate the balance between public goods and private rights would be one of the most rewarding things that I have ever done.

I have worked in the City of Emeryville for the past two years; and lived on its border for the past four years. During this this time, I have gained perspective on some of the unique opportunities and challenges the City faces. I have found the most pressing issue faced by the City to be an imbalance of jobs and housing. Proper planning by the City can provides the appropriate mixture of jobs and housing. It should be, and already is, a focus of the City to add additional housing for all income levels. If Emeryville is to take full advantage of the rapidly expanding Bay Area economy, it must have enough housing for its current and future workforce. However, proper planning is not simply building for the sake of building. The creation of new housing needs to be integrated into existing housing stock and community character. The use of height limitations, setbacks, and other tools of planning can limit stark contracts between new and old development. Focusing higher density development on arterial corridors that have access to transit is one such way that the City is currently being mindful of this balance. Transit is of course is the other major planning opportunity and constraint found in the City. Emeryville is unique in that nearly all of the major arterial roadways run north/south. The long linear nature of the City, combined with railway bisecting the middle of the City, can lead to transportation bottlenecks. Exploring ways to reduce congestion should be a priority for the City. The City's current use of bike lanes and bus services are areas that could be expanded to help create a more livable community. These efforts combined with proper siting of housing, commercial uses, and employment centers are the critical items for creating a community that all can enjoy.
