RECOMMENDATION

Staff has no recommendation. Appointments to Community Advisory Committees are made at the City Council's discretion. A separate Resolution will be approved for each set of Advisory Committee appointments.

BACKGROUND

Each fiscal year, the City Council appoints community members to serve on the City's various Community Advisory Committees ("Committees"). Committees are an opportunity for community members to have input on specific programs and initiatives of the City. All Committee meetings are publicly noticed and the public is encouraged to attend. Actions taken by Committees are forward to the full City Council for consideration and final action, with the exception that the Planning Commission and Housing Advisory and Appeals Board are allowed some independent regulatory powers, with some decisions subject to City Council review or appeal.

There are several impending scheduled vacancies on the various Committees due to terms which expired on June 30, 2018. Notice of the vacancies was posted on the City's three bulletin boards. In addition, the City Clerk's Office included noticing of the vacancies on the City's website, Twitter and ETV Cable Channel 27, and made announcements at City Council meetings. City Clerk staff contacted previous applicants, as well as incumbents, to determine whether they had continued interest in serving on the Committees. Applications were due June 11, 2018.

The City of Emeryville's Community Advisory Committees consist of various community members representing a specific demographic. Below are definitions of the various existing committee positions. It is not uncommon to receive an application from a candidate that fulfills the qualifications of multiple committee positions.

Business Representative	Person representing a business in Emeryville of any size.
City Labor Representative	Person representing a labor union with members represented in Emeryville.
Community Member	Person residing or working in Emeryville.
Large Business Representative	Person representing a business in Emeryville with over 56 employees.
Non-Profit Business Representative	Person representing a local non-profit business.
Resident	Person residing in Emeryville.
Resident (Dog Owner)	Person residing in Emeryville with canine ownership.
Senior Community Member	Person aged 50 years and over that is either residing or working in Emeryville, and participating in Senior Center programs.
Small Business Representative	Person representing a business in Emeryville with 55 or less employees.

DISCUSSION

The City Clerk's Office received several applications for the various vacancies from both incumbents and interested community members. Staff has also encouraged applicants to attend the City Council special meeting where they will be able to introduce themselves and answer any questions the City Council has.

Bicycle/Pedestrian Advisory Committee

The Bicycle/Pedestrian Advisory Committee consists of up to nine (9) total members. The Committee's purpose is to provide input and recommendations regarding City policies, priorities, and feedback related to the City's Bicycle/Pedestrian Plan and related initiatives.

The Committee currently has scheduled vacancies for one (1) Business Representative and four (4) Community Members. Committee member terms are for two years; upon appointment, members will serve for terms commencing July 1, 2018, and ending June 30, 2020.
