Resolution Of The City Council Of The City Of Emeryville Appointing Jonathan Hidalgo As Planning Commissioner For A Term Commencing Immediately And Ending June 30, 2019; And Christine Thomson And C. Tito Young As Planning Commissioners For Terms Commencing July 1, 2018, And Ending June 30, 2021; And Amending The FY2018-19 Local Roster Of Boards, Commissions And Committees Accordingly

RESOLVED, by the City Council of the City of Emeryville that Christine Thomson and C. Tito Young are hereby appointed as Planning Commissioners to serve on the Planning Commission for terms commencing July 1, 2018, and ending June 30, 2021; and, be it, further

RESOLVED, by the City Council of the City of Emeryville that the FY2018-19 Local Roster of Boards, Commissions and Committees is hereby amended to include the aforementioned appointments.
