RECOMMENDATION

Staff has no recommendation. Appointments to Community Advisory Committees are made at the City Council's discretion. A separate resolution will be approved for each set of Advisory Committee appointments.

BACKGROUND

Each fiscal year, the City Council appoints community members to serve on the City's various Community Advisory Committees ("Committees"). Committees are an opportunity for community members to have input on specific programs and initiatives of the City. All Committee meetings are publicly noticed and the public is encouraged to attend. Actions taken by Committees are forwarded to the City Council for consideration and final action, with the exception that the Planning Commission and Housing Advisory and Appeals Board, who are allowed some independent regulatory powers, with some decisions subject to City Council review or appeal.

On July 10, 2018, the City Council considered and appointed several community members during the annual scheduled vacancies across the Committees. However, there were several Committees left with unfilled positions due to a lack of qualified applicants. As such, the City Clerk's Office re-noticed the remaining vacancies, which included public noticing of the vacancies on the City's website, Twitter and ETV Cable Channel 27, and announcements made at City Council meetings. City Clerk staff also contacted previous applicants on file to determine if they had continued interest in serving on the Committees, as well as requesting Committee secretaries to forward the notice to

their Committee members and other interested community members. Applications were due September 9, 2018.

The City of Emeryville's Community Advisory Committees consist of various community members representing specific demographics. Below are definitions of the various existing committee positions. It is not uncommon to receive an application from a candidate that fulfills the qualifications of multiple desired demographics.

Business Representative	Person representing a business in Emeryville of any size.
City Labor Representative	Person representing a labor union with members represented in Emeryville.
Community Member	Person residing or working in Emeryville.
Large Business Representative	Person representing a business in Emeryville with over 56 employees.
Non-Profit Business Representative	Person representing a local non-profit business.
Resident	Person residing in Emeryville.
Resident (Dog Owner)	Person residing in Emeryville with canine ownership.
Senior Community Member	Person aged 50 years and over that is either residing or working in Emeryville, and participating in Senior Center programs.
Small Business Representative	Person representing a business in Emeryville with 55 or less employees.

DISCUSSION

Since the posting of the "Public Notice of Vacancies" on July 25, 2018, the City Clerk's Office received notices of resignation from incumbents on the Commission on Aging and Public Art Committee. Instead of re-posting the recruitment and extending the due date for applications, it was decided to fold the unscheduled vacancies into the existing recruitment. The Committee descriptions below include those unscheduled vacancies.

The City Clerk's Office has received several applications from interested community members. Staff has also encouraged applicants to attend the City Council special meeting where they will be able to introduce themselves and answer any questions the City Council has.
