Emeryville has a distinctively attractive aesthetic that resonates throughout much of its architecture. It is relatively easy to tell, for a local anyway, when you have crossed from Oakland into Emeryville. It is a town with its own character, and yet so many people don't associate it with much outside of the Bay Street Mall. There are many ways to expand and empower Emeryville as its own entity, unique from Oakland and Berkeley. One such growth opportunity is to carry forward the outstanding job that has already been done with bike lanes and Bicycle Boulevard. Increasing signage and expanding bike-friendly streets would make it that much easier to commute, shop, and dine around town. Another important facet of this type of growth is walkability... connecting some of Emeryville's hot spots with well-placed new commercial development and housing would be critical to this step. Easing traffic congestion, especially during rush hour and top shopping hours on weekends, along 40th Street would also go a long way to making the city more walkable and providing a more positive experience to residents, both on foot and in cars. One common way to go about this is to reduce parking lot space to disincentive driving, especially without carpooling. But there are also new and exciting methods being developed in the V2I (vehicle-to-infrastructure) technology space that are already working to reduce traffic congestion in some other cities across the country.
