SUBJECT: Consideration Of Transportation Committee Recommendation For

Requests For Loading Zones At East Bay Therapeutics, Blue Zone At Emeryville Senior Center, And Red Curb Tips On Driveways Of

1058 43rd Street And 1032 47th Street

RECOMMENDATION

Staff recommends that the City Council consider and approve the Transportation Committee's recommendations to install 40 feet of yellow loading zone in front of East Bay Therapeutics, 5745 Peladeau Street; install 20 feet of blue zone in front of the Emeryville Senior Center, 4321 Salem Street; and install red curb tips at the driveways of 1058 43rd Street and 1032 47th Street.

DISCUSSION

The City Council designates restricted parking zones and may consider the Transportation Committee's recommendations (Emeryville Municipal Code sections 4-9.01(a), (d), (e); 4-9.17)

East Bay Therapeutics requested passenger loading zone spaces in front of 5745 Peladeau Street. Per Emeryville Municipal Code 4-9.17 (b), loading zones are available for loading or unloading of persons or property for up to ten minutes. At the September 27, 2018, regular meeting of the Emeryville Public Works and Transportation Committees, the Transportation Committee recommended the installation of two loading zone spaces, which results in the loss of 40 feet of existing 2-hour green zone.

During the renovation of the Emeryville Senior Center, a portion of the existing blue curb was removed to install an accessible ramp. Additional accessible parking spaces were requested in front of the Senior Center at 4321 Salem Street. At the September 27, 2018 regular meeting of the Emeryville Public Works and Transportation Committees, the Transportation Committee recommended shortening the existing red zone and installing one additional 20-foot blue zone parking space north of the new curb ramp.

Residents of 1058 43rd Street and 1032 47th Street requested red curb tips be painted on their driveways to prevent vehicles from blocking their driveways. At the September 27, 2018 regular meeting of the Emeryville Public Works and Transportation Committees, the Transportation Committee recommended the installation of red curb tips at both residences.
