**RESOLVED**, by the City Council of the City of Emeryville directing the City Clerk to publicly notice FPPC Form 806 as required by FPPC Regulation 18705.5 disclosing the appointment of City representatives to compensated positions on county, regional and statewide bodies; and, be it, further

**RESOLVED**, by the City Council of the City of Emeryville that the 2019 City Roster of County, Regional and Statewide Bodies is hereby amended with the aforementioned appointments.
