Resolution Of The City Council Of The City Of Emeryville Amending The City Of Emeryville Master Fee Schedule For Fiscal Year 2018-19 Regarding Dockless Shared Mobility Systems

**WHEREAS**, an addition of new fees to the Master Fee Schedule is necessary at this time in order for the City to recover the costs associated with the new Dockless Shared Mobility System Ordinance (Ord.19-005), which ordinance becomes effective on May 2, 2019; and

**WHEREAS**, the City Council of the City of Emeryville held a noticed public hearing on April 2, 2019 to consider the new and updated fees; now, therefore, be it

**RESOLVED**, by the City Council of the City of Emeryville hereby amends the City of Emeryville Master Fee Schedule to establish new fees for Dockless Shared Mobility Systems, as shown in Exhibit A, attached hereto and incorporated herein.
