Economic Development and Housing Manager Chadrick Smalley provided a brief overview and responded to Council Member Patz's questions.

PUBLIC COMMENT

1. Ladonna Toliver, Wing Stop, asked to add franchisees as a small independent restaurant into the proposed ordinance.
2. Kate O' Hara, representative of EBASE Alliance, spoke in opposition of the ordinance amendment.
3. Judy Timmel stated that it was not fair for small business owners to balance their budget on the backs of their lower paid workers.
4. Marilyn Boucher, Broken Rack, spoke on various items in support of the minimum wage ordinance amendment.
5. Andrea Mullarkey, Member Leader of SEIU 1021, spoke in opposition of a minimum wage carve-out for small restaurants, stating that the carve-out will hurt poor people.
6. Liz Ortega, Alameda Labor Council, opposed the ordinance amendment.
7. Erik Hansen, Moomi's Cafe, spoke in favor of the ordinance amendment.
8. Emon Toliver, Wing Stop, stated that franchisees should be added into the definition of small independent restaurant into the proposed ordinance.
9. John Nemec, Suspender Factory, stated that he is generally in favor of a minimum wage increase, with the exception of the increase coming in July.
10. A speaker commented workers would work at other cities outside of Emeryville due the passage of the the minimum wage ordinance amendment.
11. Damon Stainbrook, Pig in a Pickle, spoke in favor of the proposed ordinance.

A motion was made by Council Member Bauters, seconded by Council Member Martinez, to adopt this Ordinance. The motion carried by the following vote:
