WHEREAS, on August 21, 2012, the City Council adopted Resolution No. 12-146 whereby directing the City Clerk to complete and publicly notice the Fair Political Practices Commission ("FPPC") Form No. 806 of City representatives appointed to compensated positions on county, regional and statewide bodies, as required by FPPC Regulation 18705.5, and accordingly all Council Members may participate in a decision to appoint a representative to a compensated position; now, therefore, be it

RESOLVED, by the City Council of the City of Emeryville that the City Council Members designated in Exhibit A attached hereto are hereby appointed to serve on the following legislative bodies as City Council representatives of the City of Emeryville for calendar year 2020, or until such persons are replaced or their commissions expire; and, be it, further

RESOLVED, by the City Council of the City of Emeryville that _____ is appointed as City representative of the City of Emeryville to serve on the Alameda County Mosquito Abatement District for a term commencing January 1, 2020, and ending December 31, _____; and, be it, further
