WHEREAS, the City contracts for the sweeping of all City-owned streets; and

WHEREAS, on September 27, 2019 the City opened a Request for Proposals (RFP) for City street sweeping services, and received one response; and

WHEREAS, the response from Contract Sweeping Services was deemed to be responsive to the RFP; and

WHEREAS, there is sufficient funding budgeted in the approved operating budget for Fiscal Years 2019-20 and 2020-21 in the Public Works Maintenance Fund and the continuation of the contract for additional fiscal years will be contingent upon the City Council appropriating funds for the applicable year(s), now, therefore, be it

RESOLVED, by the City Council of the City of Emeryville that the City Manager is hereby authorized to execute the attached two and a half (2 ½) year contract with Contract Sweeping Services, in the amount of \$238,031.64; and be it further

RESOLVED, the City Manager is authorized to execute up to two additional one-year extensions not to exceed \$95,339.00 for FY 2022-2023 and \$98,675.88 for FY 2023-2024, contingent upon the City Council appropriating funds for the applicable fiscal years, for a total contract value not to exceed \$432,046.52; and, be it, further

RESOLVED, the City Manager has the authority to enter into minor amendments provided they do not increase the total compensation of the contract.
