WHEREAS, the Capital Improvement Program ("CIP") adopted by the City Council in June 2019 includes funding for the Powell Street Overhead Joint Seal Replacement and Deck Seal Project (CIP No. 16475037); and

WHEREAS, in July 2018, the City contracted with Wiss, Janney, Elstner Associates Inc. to investigate the bridge deck cracking, expansion joint condition and overall deck integrity and prepare design documents based on the investigation results; and

WHEREAS, on October 1, 2019, the City Council adopted Resolution 19-140 awarding a contract to American Civil Constructors West Coast LLC for the construction of the project in the amount of \$249,545; and

WHEREAS, the project was substantially completed prior to the holiday season which minimized disruption to the public; and


WHEREAS, upon acceptance by the City Council the Public Works Department must then file a Notice of Completion with the Alameda County Clerk; and
