**WHEREAS**, annually, the fees charged for certain City services are reviewed and appropriately adjusted to reflect the addition of new programs and the cost of the City of Emeryville to provide these services; and

WHEREAS, the fees charged for a service may not exceed the cost of providing the service; and

**WHEREAS**, the City has complied with the notice and publication requirements provided by Government Code Sections 66016 and 66018; and

**WHEREAS**, fees charged by the City of Emeryville need to be revised to reflect additional services and changes in the costs of various services provided by the City as described in the staff report dated April 21, 2020, and as set forth in the Master Fee Schedule attached hereto as Exhibit "A"; and

**WHEREAS**, the City Council held a public hearing on April 21, 2020 to consider the revised Master Fee Schedule; now therefore, be it

**RESOLVED**, by the City Council of the City of Emeryville hereby amends the City of Emeryville Master Fee Schedule to establish modified fees as shown in Exhibit "A", attached hereto and incorporated herein.
