

## RESOLUTION NO. 20-112

**Resolution Of The City Council Of The City Of Emeryville Approving The Purchase Of Art Work For The City's Annual Purchase Award Program Entitled *Stucked* By Emeryville Artist Prabin Badhia With Funding Of Up To \$3,700 From The Public Art Fund (Fund 243) For The Purchase And Installation Of The Art Work And Acknowledging *Aerial Landscapes* By Judy Hart And *Terrace Martin* By Ronald Davis As First And Second Alternates, Respectively**

**WHEREAS**, Article 4 of Chapter 2 of Title 3 of the Emeryville Municipal Code establishes the Contributions for the Art in Public Places Program ("Public Art Ordinance"); and

**WHEREAS**, Section 3-2.404 of the Emeryville Municipal Code establishes the Emeryville Public Art Fund to implement the Art in Public Places Program; and

**WHEREAS**, the City has entered into a contract with Chandra Cerrito Art Consultants for implementation of the annual Purchase Award Program in connection with the 2020 Celebration of the Arts Exhibition ("Art Exhibit"); and

**WHEREAS**, a five-person Selection Panel made up of 1) Joey Enos as the PAC member; 2) Jennifer Walker as a community member; 3) Kerry Adams Hapner as outside arts professional; 4) Gwen Souza as Emeryville Celebration of the Arts (ECA) Board Representative; and 5) Miroo Desai as City staff representative, was appointed by the City Manager on September 17, 2020, based on the September 10, 2020 recommendation of the PAC, to review the Art Exhibit art works and make a recommendation on the selection of an art work to the PAC, for consideration by the City Council; and

**WHEREAS**, the Selection Panel convened on September 28, 2020 to review the art works and has made a recommendation to select the art work *Stucked*, by Emeryville artist Prabin Badhia for installation at City Hall, and the art work *Aerial Landscapes* by Judy Hart as the First Alternate if the proposed purchase is infeasible, and the art work *Terrace Martin* by Ronald Davis as the Second Alternate if both art works are infeasible; and

**WHEREAS**, on October 1, 2020 the Public Art Committee unanimously approved the Selection Panel's recommendation; and

**WHEREAS**, funding in an amount of \$3,700 is necessary to cover the purchase (\$700) and installation costs (up to \$3,000) associated with the art work selection, and is available in the City's Operating Budget for Fiscal Year 2020-2021 from the Public Art Fund (Fund 243); now, therefore, be it

**RESOLVED**, that the City Council of the City of Emeryville hereby approves the purchase of *Stucked* by Emeryville artist Prabin Badhia for installation at City Hall, for the fifteenth Annual City of Emeryville Purchase Award Program; and be it further

**RESOLVED**, that the City Council of the City of Emeryville hereby acknowledges the art work *Aerial Landscapes* by Judy Hart as the First Alternate; and be it further
