RECOMMENDATION

BACKGROUND

Each year, the City Council appoints members of their body to serve on City Council Committees ("Committees"). Terms for the currently serving Council Members expire on December 31, 2020.

On September 15, 2020, the City Council adopted Ordinance No. 20-022 whereby the scope of the Transportation Committee was expanded to consolidate the Transportation Committee with the Public Works Committee.

DISCUSSION

City Council Committees enable less than a quorum of City Council Members to have more detailed discussions on specific areas of the City's responsibilities that cannot be accomplished at regular City Council meetings due to time constraints. All Committee meetings are publicly noticed, and the public is welcome and encouraged to attend. Committee recommendations are forwarded to the full City Council for final consideration and possible action.

The current abbreviated roster, including descriptions of the Committees, meeting times and locations, and staff contact information, is attached to this staff report. Appointments made at this time will commence on January 1, 2021, and end on December 31, 2021.
