Resolution Of The City Council Of The City Of Emeryville As Successor Agency To The Emeryville Redevelopment Agency Adopting The Successor Agency Regular Meeting Calendar For February 2021 Through January 2022

WHEREAS, the City of Emeryville is the Successor Agency to the Emeryville Redevelopment Agency; and

WHEREAS, the City Council as Successor Agency has set the observed City holiday schedule for 2021; and

WHEREAS, on December 3, 2019, the Successor Agency adopted Resolution No. SA10-19 whereby a regular meeting date was set for January 2021; and

WHEREAS, the City Council as Successor Agency wishes to set the regular meeting schedule for February 2021 through January 2022 for the Successor Agency in accordance with the City holiday schedule; and

WHEREAS, as established in the City Council's Rules of Procedure, under Section 2.2, the Successor Agency meets on the first and third Tuesdays of each month, unless cancelled due to insufficient agenda items; and

WHEREAS, historically, the Successor Agency has not convened during the month of August or on the first Tuesday of January; and

WHEREAS, the City Council as Successor Agency historically considers religious observances when planning the proposed calendar now, therefore, be it

RESOLVED, by the City Council of the City of Emeryville as Successor Agency to the Emeryville Redevelopment Agency that the first meeting in September 2021 is hereby rescheduled to August 31, 2021; and, be it, further

RESOLVED, by the City Council of the City of Emeryville as Successor Agency to the Emeryville Redevelopment Agency that the calendar of Successor Agency regular meetings for February 2021 through January 2022 is hereby adopted and attached hereto as Exhibit A.
