

## **RESOLUTION NO. 21-11**

### **Resolution of the City Council of the City of Emeryville Acknowledging Receipt of The Report From The Alameda County Fire Department of Fire Inspections For The Fiscal Year 2019-2020**

**WHEREAS** SB1205, signed by the Governor in September 2018, amended the Health and Safety Code to add Section 13146.4 which requires an annual report of fire inspections; and

**WHEREAS**, Health and Safety Code Section 13146.4 reads as follows:

- (a) Every city or county fire department, city and county fire department, or district required to perform an annual inspection pursuant to Sections 13146.2 and 13146.3 shall report annually to its administering authority on its compliance with Sections 13146.2 and 13146.3.
- (b) The report made pursuant to subdivision (a) shall occur when the administering authority discusses its annual budget, or at another time determined by the administering authority.
- (c) The administering authority shall acknowledge receipt of the report made pursuant to subdivision (a) in a resolution or a similar formal document.
- (d) For purposes of this section, "administering authority" means a city council, county board of supervisors, or district board, as the case may be....; and

**WHEREAS**, the City of Emeryville contracts with the Alameda County Fire Department (ACFD) for fire prevention services including the fire inspections described in Health and Safety Code Section 13146.4; and

**WHEREAS**, ACFD provided a report attached as Exhibit A providing the information required by Health and Safety Code Section 13146.4 reflecting one-hundred percent compliance with required inspections for Fiscal Year 2019-2020; now, therefore, be it

**RESOLVED**, that the City Council of the City of Emeryville acknowledges receipt of the report attached as Exhibit A from the Alameda County Fire Department of fire inspections for the fiscal year 2019-2020.

### RECOMMENDATION

Staff recommends that the City Council formally accept this report.

### BACKGROUND

In accordance with the requirements set forth in California Senate Bill No. 1205, the City Council will receive an informational report outlining Alameda County Fire Department's compliance with the annual inspection requirements set forth in California Health and Safety Code Sections 13146.2 and 13146.3.

### DISCUSSION

Alameda County Fire Department personnel completed 9 inspections of educational Group E occupancies and 55 residential Group R occupancies. This represents a 100% compliance rate for known occupancies during this reporting period. A list of the inspections including dates is attached.

There is no fiscal impact.
