Resolution Of The City Council Of The City Of Emeryville Amending The City Of Emeryville Master Fee Schedule For Fiscal Year 2020-21 Regarding Dockless Shared Mobility Systems

WHEREAS, the City of Emeryville provides various services and programs to the public and collects fees to recover the usual and current expenses of the City in providing such services and programs; and

WHEREAS, annually, the fees charged for certain City services are reviewed and appropriately adjusted to reflect the addition of new programs and the cost to the City of Emeryville to provide these services; and

WHEREAS, the fees charged for a service may not exceed the cost of providing the service; and

WHEREAS, fees charged by the City of Emeryville may be revised to reflect additional services and changes in the costs of various services provided by the City; and

WHEREAS, an amendment of fees to the Master Fee Schedule is necessary in order for the City to recover the costs associated with the Dockless Shared Mobility System Ordinance (Chapter 13 of Title 4 of the Emeryville Municipal Code; Ord.19-005), which ordinance becomes effective on May 2, 2019 and the amendment to that Ordinance, which becomes effective on March 16, 2021; and

WHEREAS, the City Council of the City of Emeryville held a noticed public hearing on March 2, 2021 to consider the new and updated fees; now, therefore, be it

RESOLVED, by the City Council of the City of Emeryville hereby amends the City of Emeryville Master Fee Schedule to amend fees for Dockless Shared Mobility Systems, as shown in Exhibit A, attached hereto and incorporated herein.
