Resolution Of The City Council Of The City Of Emeryville Authorizing The City Manager To Execute A Fifth Amendment To The Professional Services Agreement With Biggs Cardosa Associates To Revise Work Scope And Budget For Engineering Design Services Related To The South Bayfront Bridge/Horton Landing Park Project, EPW 17-112 (CIP # 16475006 and 17237003)

WHEREAS, the City of Emeryville has desired to create a facility for Pedestrians and Bicyclists over the Union Pacific Railroad right of way for many years; and

WHEREAS, the City identified a Project in the General Plan and the Capital Improvement Program that allocates financial resources to fund a project called the South Bayfront Pedestrian Bicycle Bridge Project, to transform the idea into physical improvements that can be used and be of great benefit to the Community, and

WHEREAS, the Project will provide an East/West connection across the railroad tracks between Horton Street and Shellmound Street in the vicinity of Ohlone Way and 53rd Street as well as extend the Emeryville Greenway in a new segment generally called Horton Landing Park; and

WHEREAS, in November of 2015 the City awarded a Professional Services Agreement for \$400,740 to a team lead by Biggs Cardosa Associates (BCA) to provide Engineering Design Services after finding the firm most qualified; and

WHEREAS, four amendments totaling \$848,400 have been executed between the City and BCA extending time and budget for services related to design and engineering support during construction totaling, and

WHEREAS, as construction on the Project has progressed, additional services are required from BCA to continue to provide engineering support during construction as special structural inspections which were not included in the original scope of work; and

WHEREAS, BCA has provided an amended scope of work in the amount of \$153,438 for these services; and

WHEREAS, the proposed 5th Amendment is funded as follows:

RESOLVED, that the City Council of the City of Emeryville hereby authorizes the City Manager to execute the Fifth Amendment to Professional Services Agreement with Biggs Cardosa Associates, attached as Exhibit A, increasing the budget by \$153,438 for a total amount not to exceed \$1,402,838 to provide Engineering Design and Construction Support Services for the South Bayfront Bridge Pedestrian Bicycle Bridge Project, EPW 17-112, CIP# 16475006 & CIP #17237003.
