WHEREAS, The City of Emeryville must reduce the amount of trash entering creeks and the San Francisco Bay through its storm drain system as part of its Municipal Regional Stormwater Permit (MRP) administered by the San Francisco Bay Regional Water Quality Control Board; and

WHEREAS, The target trash reduction amounts anticipated in the upcoming MRP 3.0 include a 90% reduction by 2023 and a 100% reduction, or no visual impact, by 2025; and

WHEREAS, the Capital Improvement Program adopted by the City Council in June 2016 includes funding for a Large Trash Separator in Storm Drain Line, CIP #18475009; in order to reach the MRP trash reduction amounts; and

WHEREAS, on September 28, 2018, the City received 3 bids for the project and subsequently entered into a contract with Schaaf and Wheeler Consulting Civil Engineers to perform consulting feasibility studies for implementing Large Trash Separators in Emeryville; and

WHEREAS, the City is seeking funding for design and construction of an HDS unit at the north end of Emeryville east of I-80 from Caltrans through the Cooperative Implementation Agreement program; and

WHEREAS, additional consulting engineering services are now required to complete the funding requirements and prepare plans and specifications for construction of HDS units; and

WHEREAS, Schaaf and Wheeler has provided a scope of services to prepare the additional technical studies required for the CIA, provide project support and prepare the project plans and specifications for an amount of \$88,528; and

WHEREAS, the proposed Professional Services agreement is funded from existing authorized funds from Large Trash Separator in Storm Drain Line, CIP #18475009 as follows:
