Resolution Of The City Council Of The City Of Emeryville Authorizing The City Manager To Execute A Third Amendment To The Professional Services Agreement With Coastland Civil Engineering, Inc. For City Engineering & Inspection Services, Capital Projects Delivery Support, And Construction Management Services To Extend the Termination Date To June 30, 2022, And To Increase The Contract Amount By An Additional \$218,500 For A Total Contract Amount Not To Exceed \$873,148, And To Authorize The City Manager To Execute Amendments To Further Extend The Termination Date, Amend the Scope Of Work And To Increase The Contract Amount By An Additional Cumulative Amount of \$45,000

WHEREAS, on June 5, 2018 the City Council of the City of Emeryville authorized the City Manager to enter into a professional services contract with Coastland Civil Engineering Inc. to provide City Engineering services and capital projects delivery support, such as the Sherwin Williams redevelopment project and basic City Engineering Services; and

WHEREAS, City Council authorized the City Manager to amend this contract on June 9, 2019 and again on September 20,2020 extending the contract to June 30, 2021 for an amount not to exceed \$654,648; and

WHEREAS, continuing services are needed for City engineering, capital project support, and construction management services. The item before Council is a comprehensive contract for Coastland which will provide for services through June 30, 2022; and

WHEREAS, the Coastland Agreement is written to not exceed \$873,148, and

WHEREAS. funding for the Coastland Agreement third amendment in the amount of \$218,500 is included in the proposed FY 2021-22 Operating and Capital Budget and is proposed as follows:

RESOLVED, by the City Council of the City of Emeryville that the City Manager is authorized to execute amendments to further extend the termination date, to amend the scope of work, and to increase the total contract amount by an additional cumulative amount of \$45,000, contingent upon those funds having been included in an approved City Budget.
