At the Presidio, I assisted with rolling out their first paid parking program and assisted tenants in creating and implementing TDM Plans. Since working with Wareham, I have helped to plan and construct a regional transit facility, worked with an ad hoc committee in locating a bike share pod near the train station, installed EV chargers on our campus, added bike repair stations, and launched a twice monthly mobile bike repair facility. I have attended meetings of the BPAC, Planning Commission, and City Council, and follow the agendas of all, so am familiar with the cities goals, policies, and processes.
