SUBJECT: Consideration Of A Request For An ADA Blue Disabled Parking Zone At 1270 62nd Street, Emeryville, California

RECOMMENDATION

Staff recommends that the City Council approve the above referenced request.

BACKGROUND

The City received an application for an ADA Blue Disabled Parking Zone on May 3, 2021, from applicant Joe Nuni, Emeryville resident. Due to the nature of his child's disability, Mr. Nuni is requesting the installation of an ADA blue parking zone along the northern curb in front of the Nuni residence at 1270 62nd Street, Emeryville.

The application was forwarded and considered at a regular meeting of the Transportation Committee on June 10, 2021. The location of the proposed parking zone was noticed 72 hours in advance of the Committee meeting, and the Committee meeting agenda was posted as mandated by Government Code Section 54950 (the "Ralph M. Brown Act") for a regular meeting. The applicant attended the Committee meeting, and there were no members of the public in attendance in favor of or in opposition to the placement of the parking zone.

Public Works staff has recommended a 22-foot curb installed at the proposed site to best accommodate the applicant's needs. The Transportation Committee moved to approve the installation the blue parking zone and voted unanimously to forward the application to the City Council for consideration at the July 6, 2021, regular meeting. The applicant has been notified by email, and the proposed parking zone will be noticed 72 hours in advance of the July 6, 2021, City Council meeting. Any comments received will be forwarded to the City Council.

DISCUSSION

Staff requests that the City Council consider the application of Mr. Nuni for the installation of a 22-foot ADA blue parking zone in front of their residence at 1270 62nd Street, Emeryville.

It should be noted that in Exhibit B, the driveway that is shown via Google Maps has been removed during a recent renovation of the home and is not an option for the applicant. Also attached as Exhibit C is a map of the surrounding neighborhood. The bright blue line shows the walking distance to the next closest blue parking zone, located along the

southwestern corner on 63rd Street at Doyle Street, a total distance of 605 feet from Mr. Nuni's residence.

FISCAL IMPACT

The cost for staff to install the ADA disabled parking sign panel and paint the blue zone can be absorbed into the Public Works operating budget at a cost of approximately one-thousand dollars (\$1,000.00) for materials plus staff labor.

STAFF COMMUNICATION WITH THE PUBLIC

As noted above, staff will physically post around the proposed location at least 72 hours in advance of the meeting date. Staff has also communicated with the applicant about the application process.
