**Resolution Of The City Council Of The City Of Emeryville Authorizing The City Engineer To Advertise For Public Bids The Davenport Mini Park Rehabilitation, (CIP No. 16475017) And Transfer \$70,399 Of Marina Park Improvement Funds (CIP No.16495005) To Davenport Mini Park Rehabilitation, (CIP No. 16475017); CEQA Determination: Exempt Pursuant to CEQA Guideline 15301(c)**

**WHEREAS**, the Capital Improvement Program ("CIP") adopted by the City Council in June 2021 includes funding for the Davenport Park Rehabilitation Project (CIP No. 16475017); and

**WHEREAS**, the residents have requested a playground at the west end of town near the Marina; and

**WHEREAS**, a community meeting was held on March 21, 2018, to discuss the ideas and needs of the parents and children. At its September 18, 2018, regular meeting the Parks and Recreation Committee recommended increasing CIP funding for Davenport Park which included a new playground, park equipment, fencing, safety fall material and site preparation; and

**WHEREAS**, on October 16, 2018 the City Council considered the recommendation and provided direction to staff to continue and bring back a resolution at future meeting.

**WHEREAS**, the Public Works Department plans to finalize the bid package and advertise the project in early August 2021; now, therefore, be it

**RESOLVED**, by the City Council of the City of Emeryville that the Project is determined to be exempt under categorical exemption Class 1 Existing Facilities, State CEQA Guidelines Section 15301(c); and, be it, further

**RESOLVED**, that the City Council of the City of Emeryville hereby authorizes the City Engineer to advertise for public bids the Davenport Mini Park Rehabilitation, (CIP No. 16475017) and transfer \$70,399 from the Marina Park Improvement Funds (CIP No.16495005) To Davenport Mini Park Rehabilitation, (CIP No. 16475017); and, be it, further
